ORDINANCE 2023-15

AN ORDINANCE AUTHORIZING CHAPTER 10, ENTITLED "BUILDING AND HOUSING", OF THE CODE OF THE BOROUGH OF BEACHWOOD, COUNTY OF OCEAN AND STATE OF NEW JERSEY TO ESTABLISH § 10.12, "MUNICIPAL INSURANCE REGISTRATION FOR OWNERS OF RENTAL PROPERTIES" PURSUANT TO NEW JERSEY P.L. 2022, CHAPTER 92
"STATE MANDATED – RENTAL OWNERS REQUIRED TO PROVIDE PROOF OF LIABILITY INSURANCE TO THE MUNICIPALITY"

Section I: Definitions.

RENT means a tenant's regular payment to a landlord for the use of property or land.

RENTAL UNITS means a structure or part of a structure used as a home, residence, or sleeping unit by a single person or household unit, or any grounds, or other facilities or area promised for the use of a residential tenant.

MULTI-FAMILY HOMES means a single building that is divided to accommodate more than one family living separately.

Section II: Insurance requirements.

- A. The owner of a rental unit or units shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.
- B. The owner of a multifamily home which is four or fewer units, one of which is owner-occupied, shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$300,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.

Section III: Insurance Registration.

Pursuant to P.L. 2022, C.92; the owner of a rental unit or units, and the owner of a multi-family home of four or fewer units, one of which is owner occupied, shall annually register the certificate of insurance demonstrating compliance with section 1 of this Ordinance with the municipality in which the rental units, or multi-family home is located.

Section IV: Violations and Penalties.

Pursuant to the "Penalty Enforcement Law of 1999," P.L. 1999, C. 274; An owner who fails to comply with the provisions of this ordinance shall be subject to an ordinance violation fine of not less than \$500 but not more than \$5,000 per rental units and/or multi-family homes.

SECTION V. Effective Date.

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
