AN ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER II ENTITLED "ADMINISTRATION §2-21 PAYROLL PROCEDURES" OF THE BOROUGH CODE

WHEREAS, P.L.1981, c. 385 (C.52.14-15a) was amended by the Senate and General Assembly of the State of New jersey to provide that municipalities (along with other State entities) may provide for mandatory direct deposit of net pay for all employees on or after July 1, 2014; and

WHEREAS, the Borough of Beachwood has reviewed its payroll processing methods to better align and streamline functionality and increase productivity with business operations; and

WHEREAS, the Borough of Beachwood is committed to providing employee benefits designed to provide safety and reliability; and

WHEREAS, the Chief Financial Officer of the Borough of Beachwood recommends that the municipality adopt this requirement for mandatory direct deposit of net pay because it will increase the productivity of the Finance Department and it will decrease or eliminate costs associated with producing checks and replacing lost checks; and

WHEREAS, this policy will require that employees and elected officials of the municipality indicate, in writing to the Chief Financial Officer, the specific banking institutions(s) and designated checking account(s) or share account(s) or pay card to which the deposit shall be made on behalf of the employee or elected official; and

WHEREAS, the Chief Financial Officer of the Borough of Beachwood may provide for any special exceptions that may be permitted by law; and

NOW, THEREFORE, BE IT RESOLVED, that by the Borough of Beachwood Mayor and Borough Council hereby authorize mandatory direct deposit of net pay for all employees and elected officials of the Borough of Beachwood shall be made to the specific banking institution(s) or via pay card provided by each employee or elected official pursuant to N.J.S.A. 52:14-15 effective for payroll on April 12, 2024.

SECTION 1. The Governing Body here by rescinds §2-21 .3 Payment of Salaries from Payroll Account in its entirety, and replace as follows "Mandatory Direct Deposit".

After the passage of this section and upon the establishment of the payroll account, all salaries shall be paid at regular intervals, which payment of salaries shall be subject to confirmation at the next succeeding meeting of the Mayor and Borough Council.

SECTION 2. The Governing Body hereby rescinds §2-21 .4 Mayor Authorized to Sign Payroll Checks in its entirety.

The Mayor or any person as duly authorized by resolution shall sign all checks drawn on the payroll account, and this signature shall be finding on the Borough of Beachwood.

§2-21 .3 Mandatory direct deposit of net pay for all employees and elected officials of the Borough of Beachwood shall be made to the specific banking institution(s) or via pay card provided by each employee or elected official pursuant to N.J.S.A. 52:14-15 effective for payroll on April 12, 2024.

SECTION 3. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

SECTION 4.

This Ordinance shall be effective upon public hearing and adoption as of March 20, 2024.

WHEREAS, project labor agreements are pre-hire collective bargaining agreements with one or more labor organizations that establishes the terms and conditions of employment for a specific construction project; and

WHEREAS, the use of project labor agreements is beneficial for construction projects in excess of five million dollars as they lead to less disputes, delays, fair and agreed to employment terms and more efficient project management; and

WHEREAS, the Borough of Beachwood finds the use of such agreements for projects in excess of five million dollars to be beneficial, as they:

- (a) Set forth effective, immediate and mutually binding procedures for resolving jurisdictional, labor disputes and grievances arising before the completion of work; and
- (b) Contain guarantees against strikes, lockouts or other similar actions; and
- (c) Standardize the terms and conditions of employment of labor on the public works projects;
- (d) Permit flexibility in work scheduling and shift hours and times;
- (e) Ensure a reliable source of skilled and experienced labor; and
