ORDINANCE OF THE BOROUGH OF BEACHWOOD, COUNTY OF OCEAN COUNTY, STATE OF NEW JERSEY, AMENDING CHAPTER IX ENTITLED "FEES" TO ADJUST COMMUNITY CENTER RENTAL AND DEPOSIT FEES FOR RESIDENTS.

BE IT ORDAINED by the Borough Council of the Borough of Beachwood, County of Ocean, State of New Jersey, as follows

SECTION 1 Section 9-4.1 (Community Center Fees) of the Code of the Borough of Beachwood is hereby amended to modify subsections a.1 and a.2 to read as follows:

- a.1. Deposit \$500.00 for a Borough Resident per rental;
\$800.00 for a Non Resident of Beachwood
- a.2. Rental \$500.00 for a Borough Resident per rental
\$800.00 for a Non Resident of Beachwood

SECTION 2. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

SECTION 7. If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect, and for this purpose to provisions of this Ordinance are hereby declared to be severable

SECTION 8. This Ordinance shall become effective as of March 1, 2020 based upon final adoption and publication as required by law.
