# APPLICATION: Johanna Hoyer – Minor Subdivision Application – 625 Cable Avenue – Block 11.02 Lot 5.01

On behalf of the applicant, Mr. Stephan Leone, Ms. Hoyer's attorney, presented a minor subdivision application to the Land Use Board. The application proposed two conforming lots, one with a dwelling and the other vacant. Ms. Hoyer's engineer, Stewart Challoner, noted the minimum lot area required is 8,000 square feet. They proposed one lot with 9,900 square feet and the other with 10,100 square feet. The professionals noted the deed was submitted and accepted by the Board. Mr. Ulaky, the Land Use Board's attorney, confirmed the applicant agreed to comply with the comments received in CME's review letter dated May 25, 2022. Mr. Wrocklage questioned the applicant on why the vacant lot was proposed to be oversized. The applicant's engineer emphasized the vacant lot would at some point be built on. Additionally, Ms. Hoyer currently resides in the dwelling on the non-vacant lot.

On a motion to open to the public by Mr. Wrocklage, seconded by Mr. Martin, with all present in favor the above application was open for discussion.

Hearing no one wishing to be heard a motion to close to the public was entertained.
