8. Meeting open to public

- Michele made a motion to open to the public, Seconded by Jayme Emanuelli
- ii. Mayor Roma attended
- iii. Residents and Non- Residents of Beachwood attended and spoke:
 - Joann Robillard -216 Halliard Ave: Expressed concerns with Facebook posts, vendors used for 4th of July.
- The commission addressed the process of selecting vendors: an email is sent out to all the vendors and selection is on a first come first serve basis.
 - Harry owner of Harry's Smokin' BBQ expressed his concerns with how last recreation commission managed their communication and that he never received an email for this year's 4th of July.
- The commission addressed his concerns and verified that they had the incorrect email address and corrected it for future communications.
- The commission voted on waiving and vendor fees for Harry's for the remainder of 2022.
 - Melissa Roger 1225 Beachwood Blvd: Expressed her concerns on vendors used for 4th of July and the use of students for face painting, which she stated was illegal as she works in law enforcement however, she misrepresented her position, she is not law enforcement but is a civilian employee.
- The commission acknowledge her concerns and assured her the students are covered under Beachwood Recreation Commission Insurance and have always been when helping at all events. The Commission will take her other concerns into consideration when selecting future vendors.
 - Jillian Speranza owner of Magical Moments Entertainment, LLC: stated that her business Magical Moments Entertainment has been at every event since 2017 and express how upset she was that she was not being used this year.
- The commission brought to the table that Magical Moments
 Entertainment never filed any vendor forms, hold harmless agreements,

- certificate of insurance and that no vendor fees were ever paid to the Beachwood Recreation Commission since 2019.
- It was also stated that the commission voted on not using Magical Moments for 2022 events and will use local student artist for face painting for our local events.
- All the members of the recreation commission stated why they voted not using her for 2022 events.
- The commission will vote at the next meeting on using Magical Moments for 2023 events.
 - Robert Rosetta (former chairperson of the commission) –
 500 Compass Ave: Voiced his opinions and input regarding prior years recreation committee events
- The commission addressed that all minutes from 2022 and the last three months of 2021 commission meetings as required by law have not been recorded and posted on the website or located to be able to review.
- The Commission had a request on Facebook to have our Recreation Commission Meetings lived streamed. The commission does not have the money to live stream our meetings, we do not have WIFI at the meeting site. Joann Robillard commented that we could use our personal cell phones as a hot spot to do it. The commission will not use our personal cell phones to live stream.
