APPLICATION:

Richard Disbrow 845 Ensign Ave Block 3.05 lot 2 Minor Subdivision

The property is located within the 800 block (between Birch and Maple) of Ensign Ave and lies within the RB Zone District. The site presently contains a 1-story frame residence with an asphalt driveway providing access from Ensign Ave. The site is bordered to the south (rear), east (side) and west (side) by residential properties. The northern (front) boundary is created by the Ensign Ave right away.

The applicant proposes to subdivide the existing property to create a total of two (2) building lots. Both lots are proposed to provide 80 feet of frontage along Ensign Ave and each will comprise 8,000 square feet of lot area and are noted as new lot 2.03 and new lot 2.04 on the submitted subdivision plan. The existing dwelling is shown to be removed. No variances are requested as part of the subject application.

Mr. Disbrow testified in support of the application and explained that the two-family house that previously existed on the subject property has been demolished.

Mr. Disbrow also testified that he would comply with the terms and conditions of the Board Engineer's review letter dated May 5, 2015.
