APPLICATION:

ARYA Properties LLC Block 4.41, Lot's 3 & 10 233 Barnegat Blvd

The subject properties consist of Lots 3 and 10 within Block 4.41. The properties are located within the 200 block of Barnegat Blvd (between Barnegat Blvd and Compass Ave) and lies within the RB Zone. Existing lot 3 contains a 2-story dwelling, detached garage, driveway and other ancillary improvements. Existing Lot 10 is largely undeveloped and contains a gravel driveway.

The applicant proposes to subdivide the existing property to create a total of three (3) building lots. Existing lot 3 which fronts Barnegat Blvd, is shown to remain in the same configuration. Existing lot 10, which fronts on Compass Ave is shown to be divided to create two (2) conforming lots.

The applicant seeks variance relief as follows:


A variance to permit a minimum rear yard setback of 25.4 ft. provided to the existing dwelling on new Lot 3.01 whereas 30 ft. is required.

A variance to permit an insufficient rear yard setback for the existing detached garage.

A variance to permit an insufficient side yard setback for the existing detached garage.

The applicant submitted as Exhibit A-1 a plan entitled "Minor Subdivision, Tax Map Sheet No. 2, Lots No. 3 and 10, Block No. 4.41, Borough of Beachwood, County of Ocean, New Jersey" prepared by Frank R. DeSantis, PLS of Morgan Engineering & Surveying, consisting of one (1) sheet dated October 1, 2015.
