 - i. Egg Hunt

ii. Memorial Day

- 3. Plan in place to add a new coach, expand age groups and move to a weeknight (1-2 sessions)
- 4. Last year, \$40 covered 8 weeks of lessons, a T-shirt and a racquet. This year, same offer to be considered, as well as a less expensive option without the racquet, to accommodate returning participants who do not require one.

iv. Yard Sale

- 1. Same routine as last year.
- 2. Strong fund raiser for the group, residents enjoy participating in the event.

v. Yoga

- 1. Will restructure the pay and revenue structure for the teacher and Commission.
