OLD BUSINESS:

1. Restoration of Centennial Fountain

Mr. Schmidt and Councilman Zakar met with Mr. Fernandez and Public Works to determine where electric is to run from gazebo to fountain. Public Works will dig trench. Electrical work is being donated. Location of outlet to be determined by electrician and Mr. Fernandez. Still working on permits. Members discussed having a timer for the pump.

Councilman Zakar reported that he spoke with Barre Monuments regarding the engraving of 8 1/4 x 5 ½ pavers. Waiting on prices for stone and granite. Councilman Zakar also obtained suggestion from Barre regarding the recognition plaque - bronze on a stand. Will also obtain that pricing on that as well.

2. Status report on PEARL Project

Ms. Mc Nabb reported that she posted a picture of the tennis group on Facebook and received 38 likes so far. Ms. Mc Nabb thanked Mr. Schmidt and Ms. Bird for attending.

Members discussed other projects such as contest for most beautiful yard. It was suggested to hold off until next year.
